1 BACKGROUND

The Sustainable and Inclusive Belize Program – (SAIB) (5583/OC-BL) is a response to growing demands within Belize's two major economic sectors, tourism and agriculture. In 2019, the tourism sector contributed 39% to the GDP, 40% of total employment was primarily generated by Micro, Small and Medium Enterprises (MSMEs) along with a 42% contribution to total exports. Agriculture accounted for more than 10% contribution to GDP, 16.8% to overall employment and represented 93% of total goods exported in 2019. Despite the importance of both sectors in the country's economic development, these are facing common challenges that undermine competitiveness and sustainability within both sectors.

The general objective of SAIB is to improve incomes and promote sustainable livelihoods within the agriculture and tourism sectors. The specific objective is to improve MSMEs competitiveness, climate resilience and environmental sustainability. The project is being funded jointly by the Government of Belize and the Inter-American Development Bank (IDB) through a loan of US\$15 million and non-reimbursable Investment Financing Agreement of US\$800,000.00.

The program is comprised of two substantive components that will achieve the objective:

Component 1: Direct support to farmers, agricultural groups and MSMEs for Sustainable and Inclusive development.

Sub-component 1: Environmentally sustainable and climate resilient farming systems Sub-component 2: Sustainable and Inclusive Agri-Foods Markets. Sub-component 3: Sustainable and Inclusive Tourism

Component 2: Enabling environment for sustainable and inclusive development.

2 OBJECTIVE AND SCOPE OF WORK

The Extension Officer will support the Ministry of Agriculture, Food Security and Enterprise (MAFSE) in the implementation of the Sustainable and Inclusive Belize by providing technical guidance and coordination support to project activities at the District Level.

3 RESPONSIBILITIES/ACTIVITIES

Specific Activities of the Extension Officer include but are not limited to the following:

- I. Coordinate with the Implementing Entities from the SAIB project in the provision of technical, organizational, logistical and market access support at the district level.
- II. Coordinate training demonstrations, field day activities, individual farm visits, technical exchange visits, and the delivery of any other relevant extension methods to achieve the objectives of the activities listed above.
- III. Supervise the Implementing Entities from the SAIB Project in the provision of technical support for agro-business and marketing programs by evaluating farm and agro-business plans to determine eligibility for participation in the program and preparing recommendations and reports for MAFSE.
- IV. Supervise the Implementing Entities within the SAIB project responsible for the provision of extension support to target communities and beneficiaries.
- V. Participate in technical meetings with MAFSE technical staff for the planning and coordination of the project.
- VI. Collaborate with the respective units of MAFSE in developing field trials, data collection, analysis and reporting.
- VII. Collaborate in the dissemination of the communication campaign at the district level to promote the Sustainable and Inclusive Belize project.
- VIII. Actively Participate in the capacity-building component of the SAIB project.
- IX. Provide technical follow-up to the Supervisory Entity's work at the district level.
- X. Verify the report of the Supervisory Entity at the local level.
- XI. Support potential beneficiaries in the application process, such as answering questions and Belize Agriculture Information Management System (BAIMS) registration,
- XII. Support the review of compliance with eligibility criteria and documents of all farmers that have applied to be beneficiaries of the project.
- XIII. Coordinate the distribution of the Green Innovation Vouchers at the district level.
- XIV. Carry out verification checks when implementing the farm plans and Green Agri-Business Plans.
- XV. Perform any other relevant duties that may be assigned by the Coordinator of Extension.
